1. Apologies

2. Terms of Reference

Gary Smith introduced the paper. The Terms of Reference were last revised and agreed in September 2017 and should be reviewed every 3 years. The Chair and Vice-Chair should also be elected/re-elected every 3 years. The secretariat to the LNP should also be passed on every 3 years. It was proposed that new elections and the appointment of a new Secretariat should be done at the next Board meeting.

The Board discussed the terms of reference and whether the size of the board and the range of representation is still about right. There was broad agreement that it was but that a stronger reference to 'Nature Recovery' should be incorporated into the terms of reference.

Action: DG and NK to discuss with DH the proposition of one of them filling the vacant seat on the board representing the wider business sector.

Action: IM, EL, RM/PW to consider who will take on the secretariat role.

Action: All to send any further minor changes to GS by 24 June.

Action: CW-S to invite Nature North to the next Board meeting.

3. Farming in Protected Landscapes

Chris Woodley-Stewart and Adrian Shepherd gave an update on the 'Farming in Protected Landscapes' programme being launched by Defra to support farming in AONBs and National Parks. The programme launch has been delayed but further announcements are due w/b 21 June.

AONBs and National Parks will be allocated funds and these in turn will dispensed by a local assessment panel set up by each AONB/NPA. Each protected landscape will be responsible for monitoring the outcomes.

Only grants over £5,000 will have to go through the assessment panel. None of the project applications will have to go through the Rural Payments Agency (RPA).

Recruitment for new posts to help deliver the scheme is now underway.

Action: DA to share Water Directive Governance documents with the group.

Action: CWS and DH to consider whether it would be appropriate for the LNP to write to the RPA to raise concerns about the apparently arbitrary bureaucracy being applied to grant applications.

4. Nature for Climate Fund update

CT gave an update on the England Trees Action Plan and the England Woodland Creation Offer.

The England Trees Action Plan (ETAP) is a long-term vision. Government will at least treble woodland creation rates in England by the end of this Parliament. Over 80 policy actions covering 5 chapters. £500 million for trees from the Nature for Climate Fund. The England Woodland Creation Offer (EWCO) will cover capital costs; annual maintenance payments for 10 years; payments towards recreational infrastructure; payments towards forest roads and tracks. Further information can be found at https://www.gov.uk/guidance/england-woodland-creation-offer

Local Nature Recovery Strategy – the LNRS Pilots have been now concluded. Defra will be reviewing the report on Lessons Learnt. It is expected that the requirements of the Bill will come into effect in about 12 months' time.

Natural Capital Accounts - Eftec have been contracted to deliver this piece of work The contract will be completed by the end of the summer in time to report back to the next board meeting.
